FIRM REGISTRATION FORM

State law requires that a person engaging in the Practice of Surveying in this State under any business title other than the real name of one or more persons authorized to engage in public or state land surveying, whether individually or as an association, partnership, or corporation, shall file with the Texas Board of Professional Land Surveying, in the manner prescribed by the Board, a certificate stating the full name and place of residence of each person engaging in the practice and the place, including the street address, city and zip code, where the practice or business is principally conducted. Mark N/A when appropriate. Any changes to the business are to be reported to the board including closure. Mail the form to the Board office at the address noted above with a **\$32.11** fee. Each location (branch office) offering land surveying services has to be registered and pay the fee by completing the Branch Registration Form. The fee must be in the form of a check or money order (no cash) made payable to the Texas Board of Professional Land Surveying.
